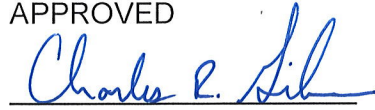

The Commission may adjourn into Executive Session to consider any item listed on

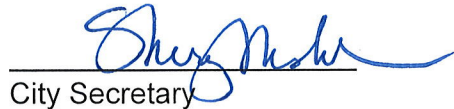
