The City uses a third-party vendor to host the virtual portion of the meeting; if virtual access is unavailable, meeting access and participation will be in-person only.

Speaker Protocol: An individual who wishes to address the Board regarding any item on the agenda, shall register with the board liaison prior to 3 p.m. on the day of the meeting. Speakers are encouraged to identify their College Station neighborhood or geographic location. Each speaker's remarks are limited to three (3) minutes. Any speaker addressing the Board through the use of a translator may speak for six (6) minutes. At the (3) minute mark, the board liaison will announce that the speaker must conclude their remarks.
